

OVERVIEW

Presbyterian Medical Services is the recipient of federal funds to provide Head Start Preschool and Early Head Start programming to eligible families in four counties in New Mexico.

The Head Start Program promotes the school readiness of participating children through the delivery of comprehensive services in the areas of education, health, nutrition, mental health, and social/emotional development.

The program supports parents and guardians in identifying and working towards goals for themselves and their family.

FINANCIAL STEWARDSHIP

Presbyterian Medical Services receives federal funds to operate the Head Start Program. Controls and monitoring systems are in place to ensure responsible use of funds.

ANNUAL AUDIT RESULTS

REDW, LLC. Conducted an independent audit for the year ending December 31, 2024. The audit report is shared with the Board of Directors and Policy Council. The auditor's report was unmodified for both financial statements and federal awards. There were no material weaknesses or significant deficiencies identified for internal control over financial reporting. There were no material weaknesses found for major federal programs. There was one deficiency noted in relation to the Health Center Program cluster and one for all major programs due to timeliness of submission of the single audit for 2023.

REVIEW BY THE SECRETARY (ACF/OFFICE OF HEAD START)

The most recent program review by the Office of Head Start was a Focus Area One monitoring review in January 2020. The review found no deficiencies, areas of non-compliance, or areas of concern.

The program had a Risk Assessment Notification monitoring review in December 2024. The review identified two areas of non-compliance. The program worked with Training and Technical Assistance Specialists to develop and implement corrective action measures.

IN-KIND / NON-FEDERAL SHARE

The Office of Head Start provides 80% of the budget required to operate the program. Each Head Start Program is required to match 25% of federal funds through cash or in-kind contributions. The non-federal match reflects the investment and commitment of the local community in this vital program.

In FY2024, the program generated a total of \$7,473,904 in cash or in-kind donations, exceeding the required \$4,444,754.

CHILD & ADULT CARE FOOD PROGRAM (CACFP)


PMS participates in the Child & Adult Care Food Program, a federal program which reimburses the organization for providing nutritious meals and snacks to children in center-based classrooms. During the 2023-2024 program year, PMS received \$763,602 in reimbursements for dietary services.




Average Monthly Enrollment




ENROLLMENT BY ELIGIBILITY TYPE




AGE AT ENROLLMENT




PROGRAM COMPONENTS

DISABILITIES

The Head Start Program makes available at least 10% of its total actual enrollment to children eligible for services under the Individuals with Disabilities Education Act (IDEA). All children are screened for developmental concerns, and the program assists families in connecting with Early Intervention or Special Education services as needed.

2024-2025 percentages of children determined eligible for services under IDEA by program and combined are shown below. The program exceeds the 10% requirement.



HEALTH MANAGEMENT

The Head Start Program emphasizes the importance of health and well-being for all children and families. Children receive health and developmental screening and program staff support parents in linking to community resources and staying on track with well-child schedules. Some health indicators for children enrolled in program year 2024-2025:

NUTRITION

The Head Start and Early Head Start Programs participate in the Child & Adult Care Food Program to provide nutritious and culturally appropriate meals to children. The program is responsible for providing 2/3 of a child's recommended daily nutrition.

The program conducts nutrition assessments on all children and supports families in accessing services and resources when a need is identified.

Educators facilitate learning through fun nutrition activities in the classroom. Three of our classrooms were recognized by CACFP for outstanding nutrition activities.



PMS served over 290,000 meals through the CACFP program in 2024-2025

MENTAL HEALTH

Presbyterian Medical Services is in its second year of learning and implementing the *Conscious Discipline* model. The second cohort of staff began their training journey, while coaching and support continued for the first group. Parents had the opportunity to learn about the model during parent engagement events.

Conscious Discipline is an evidence-based, trauma-informed approach to social-emotional learning. It provides an array of behavior management strategies and classroom structures for teachers to use in their day-to-day interactions with children.

Approximately 200 staff members completed training in the Conscious Discipline model.

EDUCATION

CLASS

The program utilizes CLASS observations to monitor and improve the quality of adult-child interactions in Head Start Preschool classrooms. CLASS®, *The Classroom Assessment Scoring System*, assesses interactions between children and teachers in three broad domains of classroom quality: Emotional Support, Classroom Organization, and Instructional Support. Each domain consists of multiple dimensions and is scored on a seven-point scale. PMS Children's Services conducts two CLASS assessments of each Head Start classroom per year. Internal assessors are trained and certified in the system. The Office of Head Start sets quality threshold targets at 6.00, 6.00, and 3.00 for the respective domains.






School Readiness & Learning Outcomes

Presbyterian Medical Services supports the growth and development of all children participating in the program through implementation of a comprehensive, research-based curriculum—*The Creative Curriculum*. Teachers observe children throughout the program year and assess progress towards developmentally appropriate learning objectives at three checkpoint periods. Results from these assessments are shared with families and aggregated to inform program decision making.

PARENT TRAINING



Parent Advocacy & Leadership Institute

Members of PMS' Policy Council participated in the Parent Advocacy and Leadership Institute. They joined parents from other Head Start Programs from across New Mexico for training and opportunities to tour the State Capitol and meet state legislators. They learned about advocating for their family and how their voice can be heard.



Conscious Discipline

Parents learned about the *Conscious Discipline* model at Family Night presentations in all four counties.



READY ROSIE

PMS utilizes a research-based family engagement and early learning application called *Ready Rosie* to partner with families and improve outcomes. Parents and guardians are provided with access to digital parenting, educational, and family development resources.

PARENT EXPERIENCE

PMS conducted a survey to collect feedback from parents and guardians on their experience with the Head Start Program. Sixty-eight percent of enrolled families responded. Results are presented below:
